- You authorise P+, former JØP to obtain relevant information about your previous pension scheme.
- Your previous pension scheme is discontinued, and the transferred amount is used for increasing the pension benefits benefits that you are entitled to in P+, former JØP.
- If your previous pension scheme includes an endowment policy or term life annuity, they are converted into one or more of the pension products that P+, former JØP offers.
- You must be aware if your previous pension scheme ensures you a cover or pension benefits which are not transferred to your pension scheme in P+, former JØP, particularly if you are ill, working in a job on flexible terms or the like.
- If your previous pension scheme includes an interest or benefit guarantee, this guarantee will no longer apply and not be transferred to P+, former JØP.
- If you have appointed a specific beneficiary in your previous pension scheme, this appointment is discontinued and replaced by the beneficiaries appointed in your existing scheme in P+, former JØP .
- 2 percent of the transferred value are set aside for MemberFunds which are a part of P+, former JØP's basic own funds. On retirement, MemberFunds are paid as a non-guaranteed supplement to the pension benefits. In general, the size of MemberFunds is fixed annually and can be changed or discontinued. - Your earliest pension age may change.
- Your possibilities for terminating your pension scheme in P+, former JØP prematurely against a cash payment are limited. If your previous pension scheme includes strict rules for prematurely termination, these rules are transferred to your pension scheme in P+, former JØP.
- The transferred pension scheme becomes subject to the same terms and conditions as your existing pension scheme in P+, former JØP.
- P+, former JØP may charge a fee of DKK 1,000 for the transfer. The ceding company may charge a transfer fee, a withdrawal penalty or another fee which may reduce your savings if they are transferred.
- The transferred pension scheme becomes subject to P+, former JØP's insurance terms etc. in force at any time.
